### **List of Procurement Clauses**

#### 101 CERTIFICATE OF CONFORMANCE:

Product must be furnished certificate of conformance, and, as applicable, material and processing certification.

## 102 1ST ARTICLE FOR PRODUCTION RUN APPROVAL:

Documented first article inspection reports shall be submitted to quality prior to the beginning of production. The supplier assumes all financial responsibility for replacement, rework and material when production of parts has begun without first article inspection approval from quality. Use of AS9102 First Article Form shall be used when stipulated in contract.

#### 103 NOTICE OF DELAY:

The supplier shall notify IPI when any delay in shipment has been identified.

#### 104 CONTRACT AMENDMENTS:

Any and all changes to Contract requirements by the supplier must be approved by IPI in writing.

#### 105 CONFIDENTIALITY:

Any information in the Purchase Order must be held in confidence by the supplier. Third party request of PO requirements, including but not limited to part numbers, product application, product usage, etc., must be approved in writing by IPI executive management.

#### 106 QUAILTY RECORDS:

Records providing objective evidence of conformity to requirements and of the effective operation of the Quality Management System shall remain legible, readily identifiable, and retrievable. The supplier shall retain such records on file for a minimum of (10) years or as specified by contract.

# 107 RIGHT OF ACCESS:

Supplier grants, at any time, IPI, IPI's customers and regulatory agencies access to visit all facilities and review all records involved with the performance of this contract. Rights to review records and visitation of facilities shall be for the purpose of assuring conformance to terms of the contract.

## 108 QUALITY MANAGEMENT SYSTEM:

Supplier, and / or approved subcontractor, shall have an established quality management system meeting the requirements of AS9100, ISO9001, or as specified by our customer. Where required, the specific quality management system shall be specified on the contract.

## 109 PROCESS CHANGES / SUPPLIER CHANGES / TRANSFER OF WORK:

Supplier shall notify IPI of changes in product and / or process, changes to suppliers, and transfer of work to a new facility. Prior to any change, IPI shall determine in writing if the change is approved to complete the work.

#### 110 NONCONFORMING PRODUCT:

Supplier shall notify IPI of nonconforming product. IPI does not grant disposition authority of nonconforming product to Supplier. IPI shall determine disposition of nonconforming product.

#### 111 SUPPLIER RESPONSIBILITY:

Supplier is responsible for compliance with all provisions of the contract and for furnishing materials and/or processes which meet all requirements of the contract whether such materials and/or processes are manufactured, processed, or provided by the supplier or procured by supplier for application to the contract. Supplier shall flow down applicable requirements—including key characteristics where required, positive FOD control processes, and ITAR requirements—to sub-tier suppliers in purchasing documents.

# 112 SUPPLIER RAW MATERIAL AND MANUFACUTRING SERVICES (SRM&M):

Supplier shall furnish with each shipment a certificate containing the following:

- Description of the material used in the manufacturing of the end item.
- Material specification and revision.
- Lot identification.
- Source of procurement.

# 114 NOTIFICATION/DISCLOSURE OF DEFECTS DISCOVERED AFTER DELIVERY



Supplier shall notify the buyer within one business day of the discovery of nonconformities that may affect already delivered product. The notification shall include a clear description of the discrepancy, parts affected, and quantities and date(s) delivered.

#### 115 FIRST ARTICLE INSPECTION REPORTS:

Supplier is required to include with all shipments a copy of all first article reports and test data pertaining to the purchase order/contract. Use of AS9102 First Article Form shall be used when stipulated in contract.

# 116 MFG OUTLINE / QUALITY PLAN:

Supplier shall include in first shipment, all process sheets/shop routers pertaining to the first article part(s).

#### 117 GOVERNMENT SURVEILLANCE:

The government reserves the right to inspect any of the material included in this purchase order or subcontract in accordance with the general specifications for the inspection of material.

#### 119 COUNTERFEIT PARTS REPORTING AND PREVENTION

Suppliers shall have a counterfeit parts detection program in place to identify and report counterfeit parts. Infinity may flow down has determined counterfeit products to be a risk, supplier names will be flowed down to the supplier. The supplier shall not purchase product from these suppliers. If raw material or product is purchased from these suppliers it shall be considered non-conforming product and it shall be dispositioned by Infinity.
